Agent-Based Computational Modeling in Public Health: From Playground to Planet

Epstein will present a wide range of mathematical and agent-based computational models of infectious disease, including pandemic flu, and other important public health dynamics, drawing parallels to contagious social phenomena generally. He will discuss his efforts to include behavioral adaptation in public health models at various scales.

Joshua M. Epstein is a professor in the Department of Emergency Medicine with joint appointments in the Departments of Applied Mathematics and Statistics, Economics, International Health, Environmental Health Sciences, Biostatistics, and the Institute for Computational Medicine. He is also an external professor at the Santa Fe Institute. He holds a B.A. from Amherst College and a Ph.D. in Political Science from MIT. In 2008, he was awarded the NIH Director's Pioneer Award, and in 2010 an Honorary Doctorate of Science from Amherst College. Among numerous articles, his books include *Growing Artificial Societies: Social Science from the Bottom Up* (MIT), with coauthor Robert Axtell; *Nonlinear Dynamics, Mathematical Biology, and Social Science* (Addison-Wesley); and *Generative Social Science: Studies in Agent-Based Computational Modeling* (Princeton).

The Jacob Marschak Interdisciplinary Colloquium was founded 50 years ago by Jacob Marschak, a pioneer in the economics of information. It is directed by Susanne Lohmann (Political Science and Public Policy) in collaboration with Sally Blower (Psychiatry and Biobehavioral Sciences), Dan Blumstein (Ecology and Evolutionary Biology), Louis Gomez (Education), Martie Haselton (Communication Studies and Psychology), and Mark Kleiman (Public Policy).
